# 62.1 Update on Senate and Council Away Days

Senate received reports on the Senate and Council Away Days. Reassurances were provided in discussion that any strategic growth in student numbers would be carefully managed to ensure that staffing and infrastructure resources kept pace. It was noted further that the University would continue to engage actively with the local community in relation to its impact on, and relationship with, the town.

### 62.2 Update on KPI Progress

Senate noted the updated KPI framework; endorsed the formal closure of the International Engagement and Impact Core Plan and associated Core Plan Board; endorsed changes to Commercial & Partnerships KPIs; and noted potential future changes to the Research and Innovation KPIs. The following points were highlighted:

- i) The rating for the Global Reputation KPI had changed from 4 (cause for concern) to 3 (moderately behind target), to reflect that the University had risen 22 places in the QS Academic Reputation Survey but remained slightly behind target; the overall E&SE Core Plan KPIs had been rated as 3, reflecting that a small number of critical metrics had moved to amber, despite continued strong performance across the majority; and the Commercial Revenue KPI had moved to 1 (ahead of target).
- ii) All four International Engagement and Impact (IE&I) KPIs were changing, and as three of the four had been subsumed into business as usual, and the other (QS Ranking) had a separate project board, the IE&I Core Plan and associated Core Plan Board would be closed. It was emphasised in this context that the University remained committed to a detailed and realistic international student recruitment plan.
- iii) The Commercial and Partnership Core Plan KPI would be changed to replace the subjective Tier 1 partnership KPI, to a data-informed KPI based on HEBCIS Plus (Higher Education Business & Community Interaction Survey).
- iv) Potential proposed changes to the R&I Core Plan KPIs were being considered to provide additional information about the quality and reach of the University's research outputs, and preparedness for the next REF.

### 62.3 <u>Update on the Higher Education External Environment</u>

Senate considered an update on the Higher Education external environment. A number of developments since the last Senate meeting in June were highlighted including: the publication of the Post-16 Education and Skills White Paper; the Greenwich and Kent merger; discussions at the UUK Autumn Conference around specialisation, differentiation and collaboration as strategic responses to sector-wide challenges; and reflections on rebuilding public trust in universities and articulating value.

#### 62.4 Financial Update

Senate noted an update on the University's Financial position for 2024/25, 2025/26 and the outer years of the forecast. Forecasting had been revised to include the potential international student levy and to increase the contingency on target PGT intakes. The position was challenging, but allowed for some optimism, albeit not complacency. It was noted in discussion that the cost management plan would be applicable across the institution.

### 25/63 GLOW (Growth, Learning, Opportunities & Wellbeing) Update

Senate noted the decisions taken by the People & Culture Board and welcomed the implementation plan for the phasing out of PDR, and the transition to Growth, Learning, Opportunities & Wellbeing (GLOW) conversations, the first deliverable of the GLOW framework. It was emphasised in discussion that academic colleagues with relevant expertise had been involved and that the People & Culture Board was working closely with the EDI team to ensure that the principles underpinning the University's approach to EDI were built into GLOW.

Key points highlighted included the appointment of all Associate Deans for EDI and most Professional Services EDI Principals; and ongoing activities to address student award gaps – targeted initiatives, including anti-racism learning modules and belonging interventions at an early stage in the student journey, were underway to reduce the gap by 2028–29.

### **SEN25-P83**

- Senate considered a report, including: Preparations for NSS and PTES with thanks offered to all involved to date; ESE portfolio development; Generative Artificial Intelligence and assessment; and Post-16 education and skills and the external regulatory and funding environment. The following points were noted in discussion of NSS:
  - i) The University was working closely with LSU on NSS preparations, and LSU would be reviewing its processes relating to the appointment of student representatives.
  - ii) Work would be undertaken with Schools to determine specific NSS start dates for each programme.
  - iii) Examples of good practice were described, including positive communications with students returning from placements, and with final year students at the end of their Semester 1 modules as well as the importance of consistency to the student experience.
